# **Regular Meeting Minutes**

#### **Opening of Meeting, Invocation, Pledge of Allegiance**

# B. Ordinance 2023-10- "An Ordinance Amending The Annual Operating Budget Of The Water And Sewer Funds Of Baxter, Tennessee For Fiscal Year 2023-2024"

Councilman Greg Phillips made a motion to approve the second reading of Ordinance 2023-10. Councilman Jeff Herald made a second to the motion.

Vote: Phillips - Yes, Stanton - Yes, Herald - Yes. Motion Carried.

#### 8. New Business - 1st Reading

#### A. Resolution 2023-9– "A Resolution To Apply To The Tennessee Department Of Economic And Community Development For Community Development Block Grant Funds"

Resolution 2023-9 passed with a motion by Councilman Dustin Stanton and was seconded by Councilman Greg Phillips.

#### B. An Agreement Between The Upper Cumberland Development District And Town Of Baxter, Tennessee Providing For Local Planning Advisory Services

Councilman Jeff Herald made a motion to approve the agreement between the Upper Cumberland Development District and the Town of Baxter for local planning advisory services. Councilman Dustin Stanton made a second to the motion.

Vote: Phillips – Yes, Stanton – Yes, Herald – Yes. Motion Carried.

#### 9. Communications from Mayor John Martin

Mayor John Martin turned this section over to Bob Lane. Bob discussed the development of townhomes and homes being developed in Baxter. Lots of buildings are being renovated. Lynn McHenry's arcade/ simulator is in process.

#### 10. Reports from Committees, Members of the Board of Mayor and Councilmen and other Officers

The Fire Chief, Public Works Director, and City Attorney did not have anything to report. Councilman Greg Phillips said everything is good and to shop local. Councilman Jeff Herald relayed he has had a lot of compliments on the new dollar store. Mayor Martin wanted everyone to know he is proud to be the City of Baxter Mayor. Jeanie Lee gave the beautification committee report. Police Chief Danny Holmes, Lieutenant Cris Austin, and Crossing Guard John Owen resigned their positions with the City of Baxter. Chief Holmes asked the Council not to micromanage the next chief. And cited one of his reasons for resigning due to feeling unneeded anymore.

Richard Waller asked Danny Holmes to stay on the planning commission. Several citizens expressed gratitude and appreciation for all three men for their service to the City of Baxter. They were also saddened to hear it.
